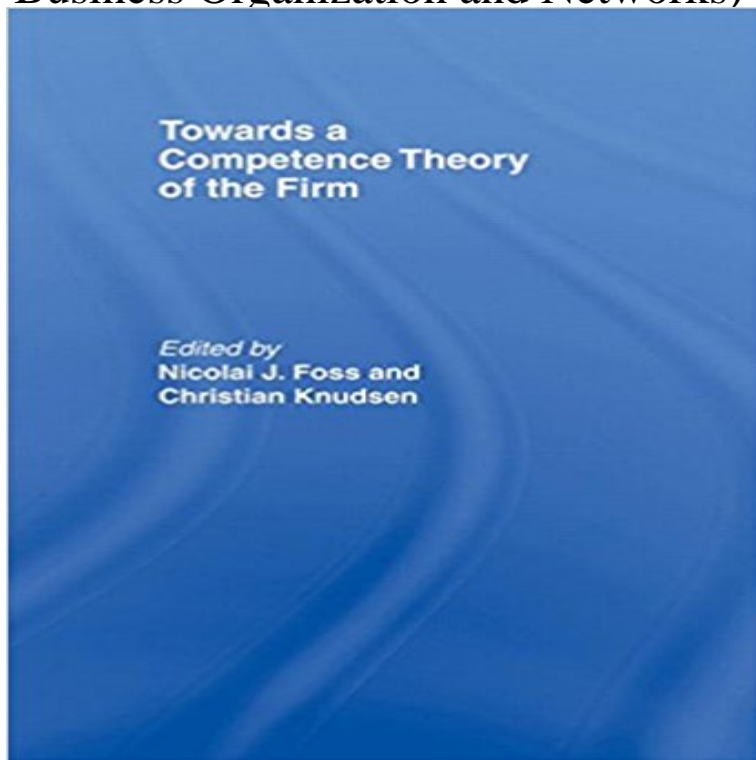


# Towards a Competence Theory of the Firm (Routledge Studies in Business Organization and Networks)
