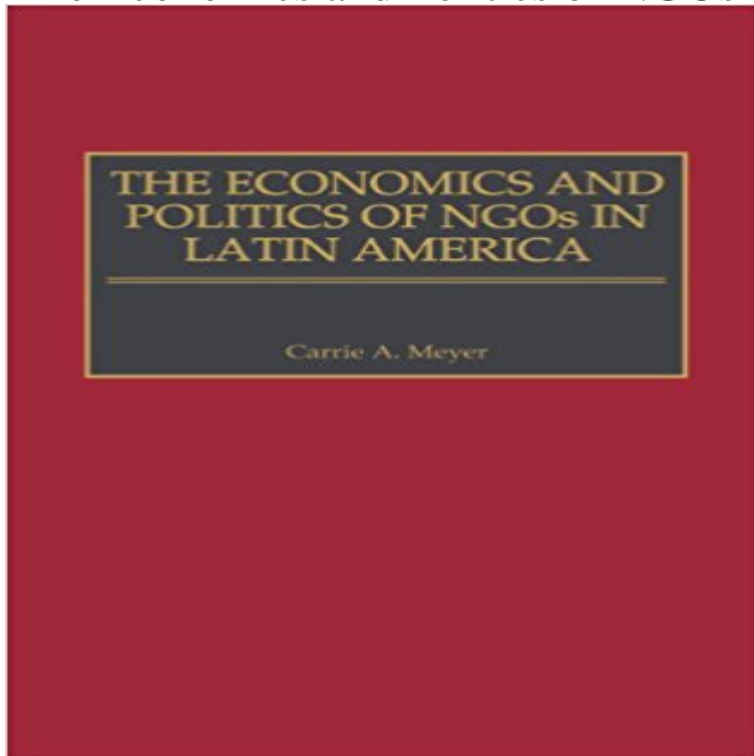


The Economics and Politics of NGOs in Latin America

This book concludes that although NGOs cannot substitute for government, they are aptly suited for complex partnerships with both domestic and international public and private sectors and are more appropriate vehicles for donor projects than Latin Americas public sectors.
