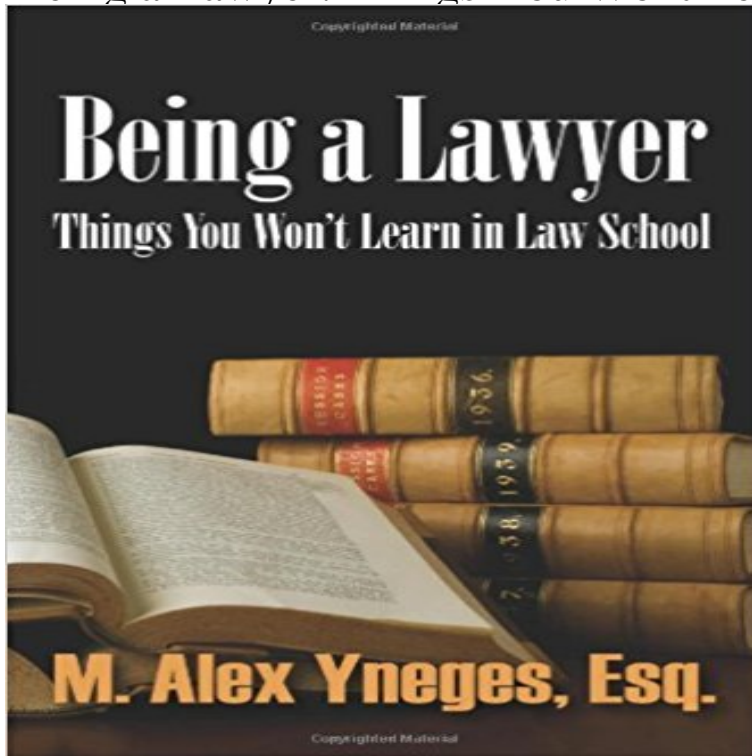


## Being a Lawyer: Things You Wont Learn in Law School
